The insured amount is capped at € 1,000,000, per claim.

The professional liability is covered regardless where in the world the error was committed and regardless where the incident occurred. However liabilities established under, and governed by the laws of the United States and/or Canada and/or which are brought to justice in the United States and/or Canada are excluded. The enforcement of judgments given by courts in the United States or Canada is therefore also excluded.
